**Fundraising Commitment Per Family:**

Each family has an annual fundraising commitment of \$150. This amount will be automatically applied to your account at the beginning of the year and appear on your invoice. As you participate in fundraisers throughout the year, credits will appear against the charge. For example, if you have participated in two fundraisers and raised \$100 in one and \$50 in another, your next invoice will show a \$150.00 fundraising charge, followed by two credits of \$100 and \$50. At the end of the season, you will be responsible for paying any remaining balance. Please do not pay this fee in advance. You may work the balance down throughout the season and pay any outstanding balance with the final payment. The program will include Kroger Gift Cards, Advertising, Swim-a-thon, US Bank Arena Events and candy sales.

New this year, once the \$150 commitment has been satisfied, any additional funds earned thru the Kroger Gift Certificate program or by working at the US Bank can be applied to the final installment on Team Program Fees.

**Meet Volunteering:**

Swim meets are an important part of the GNY swim team. The Winter Invitational, Best of the West and the Summer Invitational provide an opportunity for other teams to swim at GNY and it provides funds to support the team. Without the Invitationals, the fundraising commitment would triple. The largest meet is the Winter Invitational with five (5) sessions over the weekend and each session requires 30 workers. Each family will be asked to work three (3) of the sessions. If a family can't meet the obligation, they will be assessed a \$50 penalty charge per session missed.

The YMCA Southwest League assigns jobs to each team for A & AA Championships. GNY Parents will need to sign-up for these duties. A new League rules states that if a parent commits but does not show up or the team does not supply a person for the position, their team doesn't swim.

**Parent Board Volunteering:**

Teams do not run by themselves. Swim team programs are successful due to parent involvement. Each family will be asked to take on a small responsibility during the year such as Bronze Group photographer, newsletter assistant, swimming official or bulletin board maintenance. It is expected that most of these duties would be shared with other families.

**Meet Entry Fees:**

This account is created to prepay for the meets in which your swimmer will participate in this winter season. Each event at a meet usually costs \$3 to \$4 per swimmer. Your account must maintain a \$25 balance for your swimmer to participate in future meets.
